

THE BOROUGH OF WELWYN HATFIELD (CONTROL OF PARKING) (CONSOLIDATION) ORDER 2021 AND VARIOUS ORDERS (AMENDMENT) ORDER 2025

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred on the said County Council by Sections 1, 2, 3, 4, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

Commencement

- 1) This Order shall come into operation on **Monday 17 March 2025** and may be cited as **The Borough of Welwyn Hatfield (Control of Parking) (Consolidation) Order 2021 and Various Orders (Amendment) Order 2025** herein after referred to as "this Order".

- 3) The Amendments are as follows:

Insert in definition:

"All Zones Business Permit" means a permit issued in accordance with Article ADD1 of this Order;

After the relevant Article relating to Business permit issuance and eligibility:

ADD1) Any tradesperson who does not live at the eligible address may apply for the issue of an All-Zones Business Permit for the use when visiting households in the roads specified in Schedule(s) to this Order, as well as other Welwyn Hatfield Borough Council's on street parking permit zones. Permits will be issued to a particular vehicle. The decision to issue an All-Zones Business Permit will be at the discretion of the Council.

STATEMENT OF REASONS FOR PROPOSING

WELWYN HATFIELD BOROUGH COUNCIL

THE BOROUGH OF WELWYN HATFIELD (CONTROL OF PARKING) (CONSOLIDATION) ORDER 2021 AND VARIOUS ORDERS (AMENDMENT) ORDER 2025

Welwyn Hatfield Borough Council is proposing to amend Traffic Regulation Orders in relation to on street resident permit parking zones in **Various Roads, Welwyn and Hatfield Borough**.

The Council has recently started the process of issuing all zones business permits to accommodate tradesperson parking. For the avoidance of doubt, it is necessary to amend the existing following Traffic Regulation Orders to include definitions and articles relating to all zones business permits.
