

**THE BOROUGH OF WELWYN HATFIELD (VARIOUS CAR PARKS, HATFIELD) (OFF-STREET PARKING PLACES) ORDER 2021 (AMENDMENT NO.1) ORDER 2025**

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred on the said County Council by Sections 32, 33, 34, 35, 44, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended by the Road Traffic Regulation (Parking) Act 1986) and Section 43 and Schedule 3 of the Road Traffic Act 1991 and the provisions of Part 6 of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:

Commencement

- 1) This Order shall come into operation on **DDMMYYYY** and may be cited as **The Borough of Welwyn Hatfield (Various Car Parks, Hatfield) (Off-Street Parking Places) Order 2021 (Amendment No.1) Order 2025** herein after referred to as "this Order".

Interpretation

- 2) The following Order herein after referred to as "The Amended Order" shall be amended but only in so far as they are effected by the restrictions of this Order:

*The Borough of Welwyn Hatfield (Various Car Parks, Hatfield)) (Off-Street Parking Places) Order 2021*

- 3) The Amendments are as follows:

Schedule 1 of the Amended Order: Plan Numbers HAT/MSCP/10 and HAT/MSCP/LevelG/02 to be replaced by a new plan HMSCP/GF/2025/01

To insert at the end of Article 3 of the Amended Order:

"Electric vehicle charging disabled bay" means an area contained within a Parking Place marked by yellow road markings to indicate the position in which a vehicle may be parked, for use by a disabled person's vehicle displaying in the relevant position a disabled persons badge in which an Electric Vehicle may be parked charging and as identified in the key and shown on the accompanying plans;

To insert at the end of Article 8 of the amended Order:

Within a parking place no person shall, cause or permit any motor vehicle to wait at any time in an electric vehicle charging disabled bay as shown on the Off-Street Plans and indicated in the key on the accompanying plans unless it is;

- (a) an electric vehicle or plug in electric hybrid vehicle; and
- (b) the electric vehicle or plug in electric hybrid vehicle is connected to the recharging post and actively recharging, via the recharging lead, for a period of up to 4 hours with no return within 4 hours during the car park charging days and hours; and
- (c) displaying in the relevant position a valid disabled person's badge

- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an act of parliament.
