# THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, HOLLYBUSH, WELWYN GARDEN CITY) (PROHIBITION OF STOPPING AND WAITING ON VERGE OR FOOTWAY) ORDER 2025 ORDER 202X

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 Local Government Act 2000 and The Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers of the said County Council under Sections 1(1), 2(1) to (3), 3(2), 4(1) and 4(2) of the Road Traffic Regulation Act 1984 (herein referred to as "the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby makes the following Order:-

 This Order may be cited as "The Borough of Welwyn Hatfield (Various Roads, Hollybush, Welwyn Garden City) (Prohibition of Stopping and Waiting on Verge or Footway) Order 2025 (Amendment) Order 202X" and shall come into effect on DD MM YYYY

## 2. Interpretation –

"The Amended Order" relates to "The Borough of Welwyn Hatfield (Various Roads, Hollybush, Welwyn Garden City) (Prohibition of Stopping and Waiting on Verge or Footway) Order 2025."

### 3. Amendment

The Amendments are as follows:

In The Amended Order to remove the plan reference HBN01-2024-3, HBN01-2024-4 from Article 2 "accompanying plans" and from Schedule 2, and insert in its place in both said Article 2 and Schedule 2 (Check its in that article and schedule of original order) with: HBN-2025-3V2 and HBN-2025-4V2

- 4. The restrictions imposed by this Order shall only to be to amend an existing Traffic Regulation Order and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by under any other enactment.
- 5. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
