

## ROAD TRAFFIC REGULATION ACT 1984

### WELWYN HATFIELD BOROUGH COUNCIL

#### THE BOROUGH OF WELWYN HATFIELD (CONTROL OF PARKING) (CONSOLIDATION) ORDER 2021 AND VARIOUS ORDERS (AMENDMENT) ORDER NO. 2 2026

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred on the said County Council by Sections 1, 2, 3, 4, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984 hereby makes the following Order:-

#### Commencement

- 1) This Order shall come into operation on **Monday 5 January 2026** and may be cited as **The Borough of Welwyn Hatfield (Control of Parking) (Consolidation) Order 2021 and Various Orders (Amendment) Order No. 2 2026** herein after referred to as "this Order".

- 3) The Amendments are as follows:

In the Amended Orders **insert** in interpretation section:

"Personal carer permit" means a permit issued in accordance with Article SC1) of this Order;

**Insert** in each of the Amended Orders after the relevant Article relating to "Eligibility for a Parking Permit or Parking Vouchers":

PC1) Any person who is the owner of a motor vehicle may apply to the Council for the issue of a Personal carer permit, subject to the maximum Parking Permit allocation per household set out in Schedule to this Order. A Personal carer permit may be issued to an applicant who resides outside the relevant permit zone, for use when visiting an eligible permit address where the resident holds a valid Disabled Person's Badge. Applicants must provide proof of a valid Disabled Person's Badge registered to the eligible address, along with evidence that the vehicle is registered and insured at an address outside of the applied permit zone. The Council retains discretion over the issuance of the Personal carer permit and may carry out additional checks to confirm the Disabled Person's Badge is registered to the eligible address. The permit holder may surrender the permit at any time. The Council may, by recorded delivery or by email send to the address provided on the application or any other known addresses of the permit holder, to withdraw the permit if the Council determines that the permit holder is no longer eligible – inclusive of the Disabled Person's Badge no longer being valid, or registered to the eligible permit address.

Personal carer permit	Maximum of one permit per eligible address, when resident is in receipt of disabled badge registered to that permit address.

Personal carer permit	£44.00 per annum

**Insert** an additional line at the end of each Schedule table relating to "Refunds" in the Amended Orders:

Permit type	Refund
Personal carer permit	Pro rata to the nearest month on amounts above £11.50

- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.
- 5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an act of parliament.

## **STATEMENT OF REASONS FOR PROPOSING**

WELWYN HATFIELD BOROUGH COUNCIL

### **THE BOROUGH OF WELWYN HATFIELD (CONTROL OF PARKING) (CONSOLIDATION) ORDER 2021 AND VARIOUS ORDERS (AMENDMENT) ORDER NO. 2 2026**

Welwyn Hatfield Borough Council is proposing to amend Traffic Regulation Orders in relation to on-street resident permit parking zones in **Various Roads, Welwyn and Hatfield Borough**.

The Council proposes to introduce a personal carer permit permit for disabled residents. For the avoidance of doubt, it is necessary to amend the existing following Traffic Regulation Orders to include definitions and articles relating to the permit.
