## **STATEMENT OF REASONS FOR PROPOSING**

### **WELWYN HATFIELD BOROUGH COUNCIL**

#### **THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, SHERRARDS, WELWYN GARDEN CITY) (RESTRICTION OF WAITING AND PERMIT PARKING ZONES) ORDER 2023 (AMENDMENT) ORDER 2026**

Welwyn Hatfield Borough Council (pursuant to arrangement made with Hertfordshire County Council) proposes to introduce waiting restrictions in **Walden Road, Welwyn Garden City** under the Road Traffic Regulation Act 1984 (as amended). The amendment is in order to introduce additional sections of double yellow lines following a review of the parking restrictions introduced in 2024.

The general effect of the Order would be to introduce additional parking restrictions in the following roads:

#### **Double Yellow Lines**

Walden Road

It is intended that these measures will:

- **Reduce instances of inappropriate or inconsiderate parking**
- **Improve access to adjacent properties**

The proposals have been developed following a consultation with residents, Borough and County Councillors, Hertfordshire County Council, Hertfordshire Constabulary and all other statutory consultees, taking into account Section 122 of Road Traffic Regulation Act 1984.

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred on the said County Council under Sections 1, 2, 3, 32, 33, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part IV of Schedule 9 of the Act of 1984, Regulation 21 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996, and of all other enabling powers and after consultation with the Chief Officer of Police hereby make the following Order:-

1. This Order may be cited as "**The Borough of Welwyn Hatfield (Various Roads, Sherrards, Welwyn Garden City) (Restriction of Waiting) Order 2023 (Amendment) Order 2026**" and shall come into effect on Monday 16 March 2026

2. **Interpretation –**

"The Amended Order" relates to "The Borough of Welwyn Hatfield (Various Roads, Sherrards, Welwyn Garden City) (Restriction of Waiting) Order 2023"

3. **Amendment**

The Amendments are as follows:

In The Amended Order to add into Article 2, the plan reference **SHPZ-01-2023 Rev2**

In The Amended Order to add into Schedule 2, the plan reference **SHPZ-01-2023 Rev2**

4. The restrictions imposed by this Order shall only to be to amend an existing Traffic Regulation Order and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by under any other enactment.
5. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

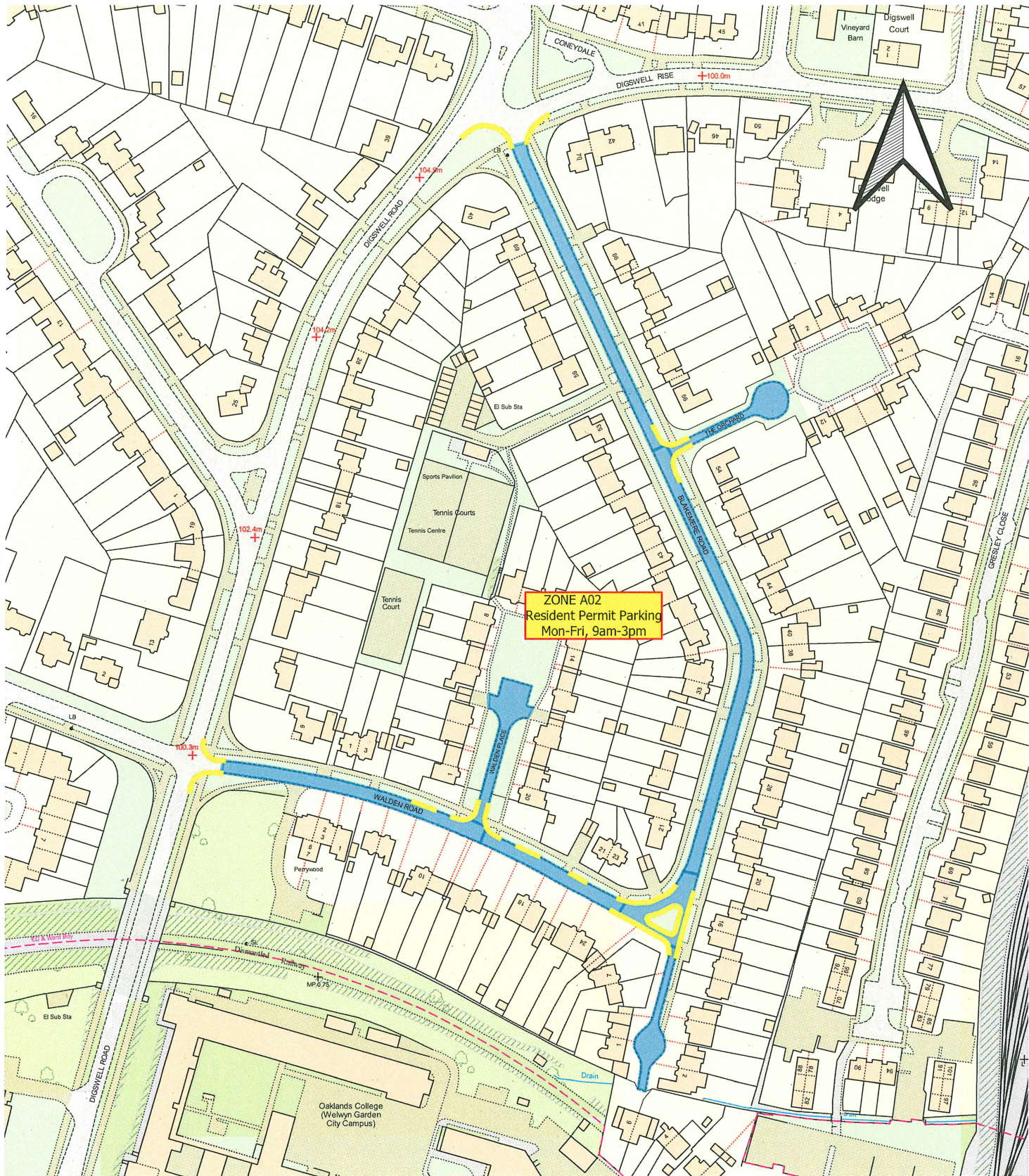
