Dear Resident/Occupier,

Birchwood Parking Consultation – Great North Road

Parking Services have received complaints from residents in Great North Road that they are not able to find sufficient parking within a reasonable distance from their home. This is particularly difficult during the working week, Monday to Friday. This lack of parking was attributed to a number of groups including local workers, commuters and visitors to the businesses. The residents have requested for some areas in Great North Road to be for residents only.

In addition, a number of complaints have been received from people trying to drive up and down Great North Road, finding this difficult due to vehicles parking on both sides of the road. Therefore, the road has been investigated on safety grounds to see if sections of yellow lines need to be introduced, to try and provide passing points to make this safer for all types of traffic.

Unfortunately, there is not one restriction which would address all of the issues which have been raised and after talking to a number of businesses it was obvious that parking was needed at different times of the day and night. So to add a single yellow lines between the hours of 8-9am would potentially address the commuter issue, but local workers and businesses in Great North Road would also be affected.

Therefore, Parking Services have taken the approach to introduce some resident parking only bays and some small sections of double yellow lines to improve safety, but left the remainder of the road unrestricted.

The enclosed plan is the outcome of these consultations and investigations. The plan indicates where proposed changes will be taking place. Any other restrictions which are already in operation but are not marked on the plan, will remain as they currently are.

Comments and other suggestions are welcome, please send these using the contact details at the top of this letter by the 23rd June 2017. These will be considered and possible changes to the proposals may be made in response to comments received.


