

**WELWYN HATFIELD BOROUGH COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

THE BOROUGH OF WELWYN HATFIELD (STATION ROAD, CUFFLEY) (PARKING PLACES) ORDER 2019

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and The Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012 in exercise of the powers conferred under Sections 32 and 35 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and Part IV of Schedule 9 of the Act of 1984, and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

1. (a) This Order may be cited as "The Borough of Welwyn Hatfield (Station Road, Cuffley) (Parking Places) Order 2019" and shall come into effect on Monday 10th June 2019.
(b) In this Order-
"disabled person's vehicle" has the same meaning as in Section 142(1) of the Act of 1984;

"disabled person's badge" has the same meaning as given in Regulation 3(1) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and

"relevant position" has the same meaning as given in Regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.
2. That length of Station Road, Cuffley specified in Schedule 1 to this Order is authorised for use as a parking place at any time, for disabled persons vehicles which display in the relevant position a disabled persons badge.
3. Save as provided in Article 6 of this Order, where in Article 2 of this Order a length of road is described as authorised for use as a parking place at any time, for disabled persons vehicles which display in the relevant position, a disabled persons badge, the driver of a vehicle shall not permit the vehicle to wait in that parking bay unless it is;
(a) a disabled persons vehicle on which is displayed in the relevant position a disabled persons badge; and
(b) the vehicle is wholly parked within the marked limits of the parking place.
4. Those lengths of road specified in Schedule 2 of this Order are hereby authorised for use as parking places effective between 8am and 6:30pm Monday to Saturday inclusive, limited to 30 minutes waiting with no return within the next 1 hour.
5. Save as provided in Article 6, 7, and 8 of this Order, the driver of a vehicle shall not permit the vehicle to wait in a parking place authorised by Article 4 to this Order, unless it is -
(a) wholly parked within the marked limits of the parking place; and
(b) waiting for no more than 30 minutes (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

6. (1) Nothing in Articles 2, 3, 4 and 5 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred to in this Article as "the restricted area") in relation to-
- (a) A vehicle being used for Fire and Rescue, Ambulance or Police purposes.
 - (b) Anything done with the permission of or at the direction of a Police Constable in uniform; or with the permission of a Civil Enforcement Officer as defined by the Traffic Management Act 2004 and appointed by Welwyn Hatfield Borough Council.
 - (c) A vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
 - (d) A vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;
 - (e) A marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

In this Article –

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in Section 65 of the Postal Services Act 2011.

6. (2) The "purposes" referred to in sub-Article (1)(d) of this Article are –

- (a) any operation involving building, demolition or excavation;
- (b) the removal of any obstruction to traffic;
- (c) the maintenance, improvement or reconstruction of a road;
- (d) constructing, improving, maintaining, or cleaning of any street furniture; or
- (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.

7. Nothing in Articles 4 and 5 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred to in this Article as "the restricted area") so as to render it unlawful to cause or permit any vehicle to wait only for so long as may be reasonably necessary

–

- (a) to enable goods to be loaded on or unloaded from the vehicle from or to premises adjacent to the restricted area; or
- (b) to enable a passenger to board or alight and to load and unload any luggage.

8. Nothing in Articles 4 and 5 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, to wait at any time in the lengths of road specified in Schedule 2 of this Order.

9. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

10. The provisions of the following Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order -

The Borough of Welwyn Hatfield (Control of Parking) (Consolidation) Order 2017

11. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

Schedule 1 :		
Disabled Badge Holders Only at any time		
Road & Side		Length and description
Station Road Southeast Side		From a point 2.5 metres northeast of a point in line with the boundary between numbers 20 and 22 south-westwards for 9 metres

Schedule 2 :		
Parking Limited to 30 minutes waiting with no return within the next 1 hour Monday-Saturday 8am-6:30pm		
Road & Side		Length and description
Station Road Southeast Side		From a point in line with the south western flank wall of numbers 48 and 50 Station Road north-eastwards for 19 metres (continuous bay)
