French Horn Lane Area Parking Consultation – Modification no.2

Further to our letter sent 4th March and the public Notice 20th March regarding the proposal for new parking restrictions in various roads Hatfield. As a consequence of responses received from Glebe Court sheltered housing to the Notice of Intention published on 20th March 2019, the Council is proposing to modify the order The Borough of Welwyn Hatfield (Various Roads, French Horn Lane Area, Hatfield) (Restriction of Waiting, Parking Places and Permit Parking Zones) Order 2019. The effect of the modification shown in the attached plan will be as follows:

- To change the proposed restriction outside Glebe Court from “permit parking only” to parking bays restricted to “2 hours no return within 2 hours or permit parking zone B02”

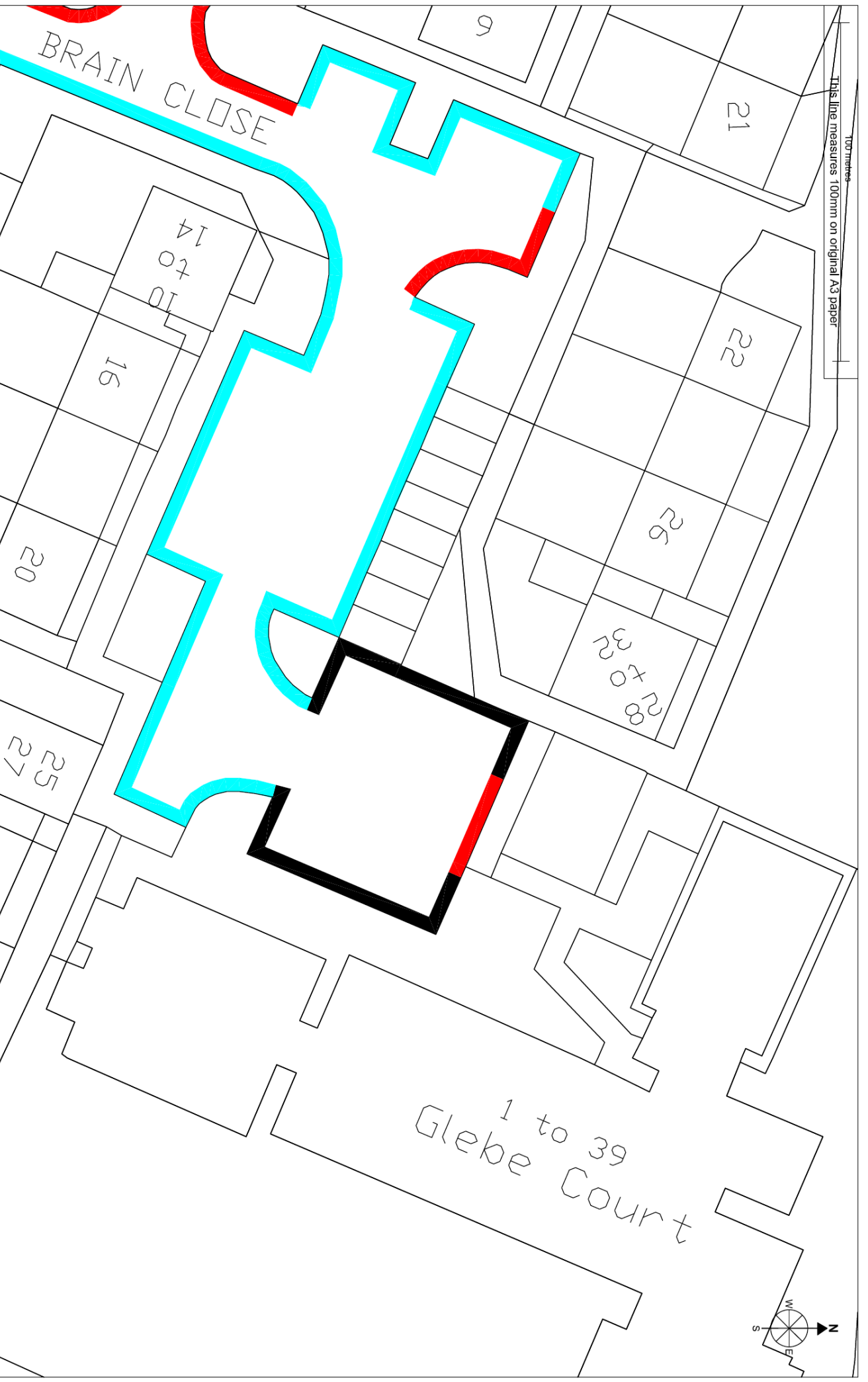
